CASA BOARD MEETING - 5/19/2020

I. STANDARD BUSINESS

The meeting was called to order by Courtney Reich at 12:06pm.

Approval of Meeting Agenda was Motioned by Penny Rafferty, and seconded by Jacobium Holliman. Motion passed.

II. BOARD CHAIR REPORT

- a. 3/24/2020 Meeting Recap
 - i. Fundraising has been difficult due to CoVID-19. Board Members were asked for fundraising ideas. Courtney asked how to include a virtual component to "Dancing with Savannah Stars" (DWSS). Faith mentioned at last Communications meeting that DWSS may be completely virtual. Suggestions included:
 - 1. Dancer engagement on personal social media pages
 - 2. Raffle ideas
 - 3. Virtual 5k
 - 4. Virtual golf tournament
 - 5. "Cute Kid Song" Contest or "Best Family" video
 - 6. Jingles contest to increase publicity of DWSS campaign
 - 7. "Viewer's Choice" award, which will be an incentive for dancers to get attendees to buy virtual tickets
 - 8. Dance-A-Thon: volunteer and Board Members dance for one hour; Mandy and Holly will research dancer assignments.
 - ii. Kayla researching platforms to conduct DWSS auctions digitally.
 - iii. Holly H. suggested creating a "Get to Know" video to highlight DWSS dancers in an effort to introduce them to the audience. Kate mentioned that one of the dancer's husband is a videographer, and may be willing to create the video. His efforts will go towards the dancer's in-kind giving.
 - iv. One additional dancer is needed. Kayla asked Joe (recommended by Penny), who has not yet fully committed. Penny will follow-up with Joe directly to confirm his participation.

III. TREASURY REPORT

Kate delivered the Treasury report in Chris' absence.

- a. Individual giving is currently \$6k vs \$700 this time last year.
- b. Board members are encouraged to initiate FB fundraisers.
- c. There will be no major changes to grants due to CoVID-19. Kate is concerned with fundraising, as April funds do not include PPP loan. She anticipates \$40k of the PPP loan will be forgiven. Terry asked if we will be able to spend all PPP monies. We were awarded \$66k, and have spent \$40k currently. It has been difficult to spend 5% of the loan due to not having a rent payment. Terry suggested to give staff an additional bonus and contribute to their 403b to ensure all loan monies are utilized. Kate requested board members to email her and/or Courtney with additional suggestions of ways to spend the monies by 6/30/2020. Loan has 1% interest, thus Kate recommends keeping the monies if fundraising remains low.
- d. Currently in the middle of the audit. Financials are available in the packet for review if anyone has questions. \$98k can be cut from expenses if training classes and volunteer management are eliminated. Mileage is currently less than \$400/month due to staff working remotely.

IV. COVID UPDATE

- a. Staff will continue to work remotely until 6/30/2020.
- b. 62% advocacy rate. Seen less cases since CoVID. There are 20 enrolled in the current Volunteer class. No child has been denied a CASA this year. Most children in-take are prompted by school/teacher reporting. Per Kate, Coastal Children Advocacy have reported an increase in assault cases. The Rape Crisis Center has reported an increase in sexual assault against teens.

V. COMMITTEE UPDATES

- a. Antwan Lang provided an update on behalf of the Communication & Development committee.
 - i. Committee Fundraising Goal: \$15,000.
 - ii. "Giving Tuesday" (5/5/2020) raised \$1,305 (FB generated \$490; Mailers generated \$815)
 - iii. Suggested the following fundraisers:
 - 1. Virtual 5k
 - 2. "Giving a Purpose to Give" video, highlighting a foster child's story, in which they will communicate ways that CASA has benefited them.
 - 3. Virtual Concert with local bands
- b. Policy Committee: Per Kate, all board members are to sign their board contracts. Board Development meetings will start in June.
